I/We understand that St. La Salle School's tuition policy requires the following:

Tuition is due the 1st of the month and is delinquent after the 15th (\$20.00 late fee).

At the end of the semester or anytime during the school year, the school may discontinue enrollment of students whose families have not made sufficient payment toward a delinquent account. Families with delinquent accounts will not be allowed to re-register for the following school year until delinquent

accounts are fully paid. 8th grade students who are graduating will not be able to participate in the graduation ceremony and their diplomas will be held if payment is not received for delinquent tuition.

Payments made by check which are returned for insufficient funds will be charged a \$20.00 fee for each occurrence. After two returned checks, families must pay tuition by cash or money order.

Parents will be held responsible for reasonable attorney fees and collection cost necessary for collection of any amount not paid when due.
